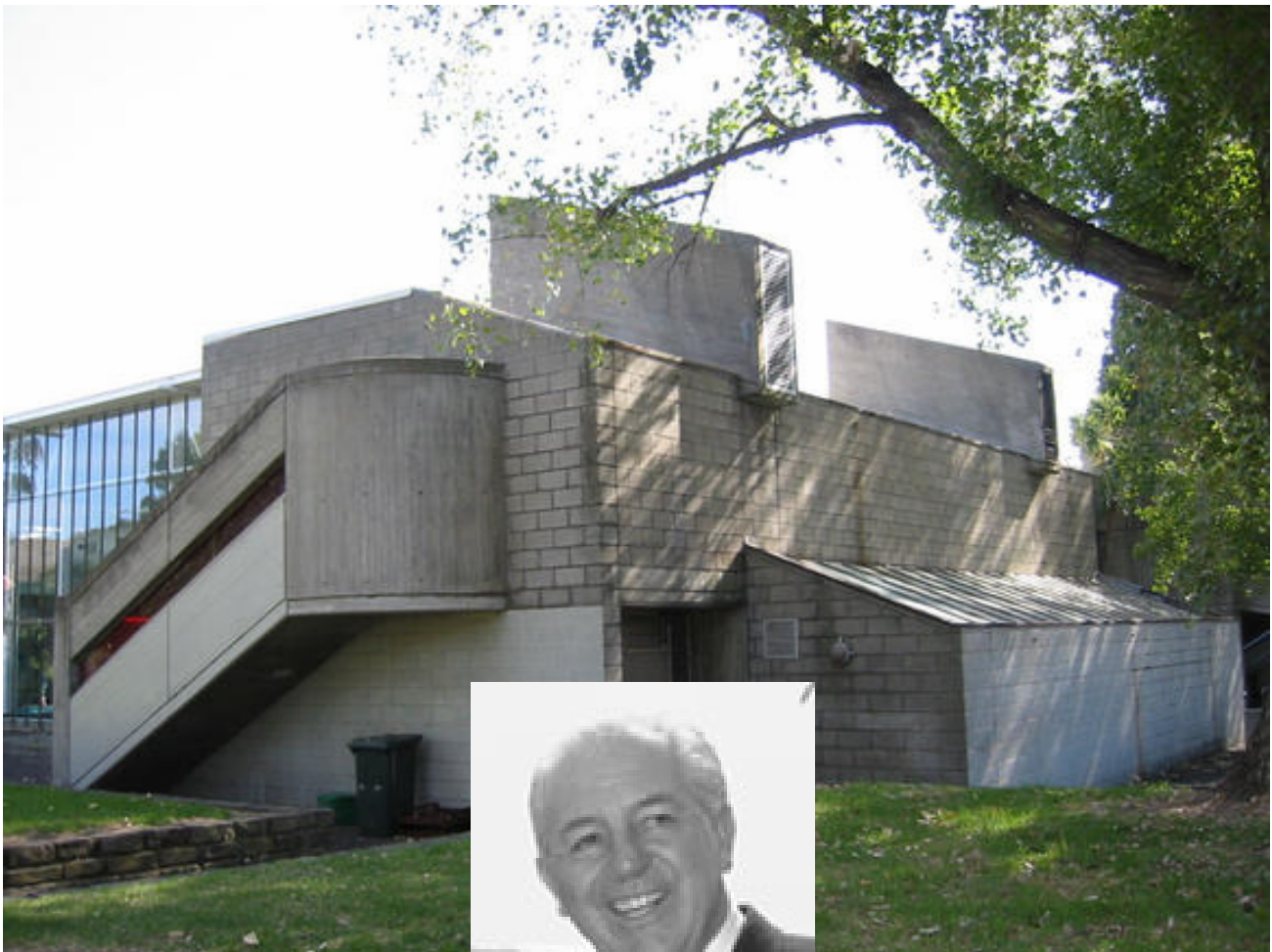


**IT'S NOT TOO LATE TO

The Harold Holt Memorial Swimming Center was designed by Kevin Borland and Daryl Jackson in the late 1960s. It is an architectural work of boldness, openness and vision. The recent inclusion of the Harold Holt building on the Victoria Heritage Register is recognition of its importance in the development of Australian Architecture. Its integrity must be protected.

This is not simply a local planning matter. The Harold Holt Memorial Swimming Center is a building of national significance. The planning process to date has failed to recognize this fact and it is important that it now does so.
